

**CONSENT AGREEMENT  
BETWEEN  
JEFFREY L. MILLER  
AND THE  
STATE OF OHIO COUNSELOR AND SOCIAL WORKER BOARD**

This CONSENT AGREEMENT is entered into by and between JEFFERY L. MILLER, hereinafter, "MILLER", and the STATE OF OHIO COUNSELOR AND SOCIAL WORKER BOARD, hereinafter "BOARD", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

MILLER hereby acknowledges that he has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

MILLER is fully aware of his rights, including his right to be advised by counsel and his right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. MILLER is a professional clinical counselor (E-3524) and professional counselor (C-6207) licensed to practice counseling in the state of Ohio, and is subject to the laws and rules of Ohio regulating the practice of counseling as outlined in Ohio Revised Code Chapter 4757. MILLER received his counselor licenses on May 18, 2000, and January 29, 1999, respectively.
2. MILLER was employed as a counselor from approximately October 1999 to present, with Choice Behavioral Healthcare, Fairlawn, Ohio, and from

approximately June 1996, to July 2001 as superintendent for Twinsburg Schools. In April 2002, MILLER was indicted on 12 felony counts which included theft in office, insurance fraud, perjury, and forgery. If convicted, these charges would result in violations of Ohio Revised Code sections 4757.36 (A)(1,2)(5) and (7).

3. As a part of a plea agreement, MILLER offers to permanently surrender his professional clinical counselor license and his professional counselor license.
4. MILLER admits the statements referenced in paragraphs 1,2, and 3 referenced above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any further formal disciplinary proceedings, MILLER knowingly and voluntarily agrees with the BOARD to the following terms and conditions:

1. The BOARD will allow MILLER to permanently surrender his counseling licenses, with the understanding the surrender is in lieu of potential disciplinary action. MILLER will not be allowed to apply for a counselor or social work license in the State of Ohio.

It is hereby agreed by and between both parties that this CONSENT AGREEMENT hereby settles all issues concerning this matter.

By his signature on this CONSENT AGREEMENT, MILLER acknowledges that in the event the BOARD, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. MILLER agrees that should the BOARD reject this CONSENT AGREEMENT and if this case proceeds to hearing, he will assert no claim that the BOARD was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.

MILLER hereby releases the members of the BOARD, its officers and employees, jointly and severally, from any and all liability arising from the matter within.


This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the BOARD may be required to provide MILLER'S social security number to requesting governmental agencies.

The BOARD shall incorporate this CONSENT AGREEMENT into a formal journal entry at its Sept 20, 2002, meeting.
