**CONSENT AGREEMENT
BETWEEN
PAT RUSSELL-CAMPBELL
AND THE
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between PAT RUSSELL-CAMPBELL, hereinafter, "RUSSELL-CAMPBELL," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

RUSSELL-CAMPBELL hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

RUSSELL-CAMPBELL is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, based on the Board's investigation, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT. This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. RUSSELL-CAMPBELL is a social work assistant (W.0001306) registered to practice as a social work assistant in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. RUSSELL-CAMPBELL received her social work assistant registration on November 17, 2000.
2. RUSSELL-CAMPBELL renewed her social work assistant registration through November 17, 2014. In October 2012, RUSSELL-CAMPBELL was audited for compliance with continuing education requirements. On May 6, 2013, the Board received an e-mail from RUSSELL-CAMPBELL where she states she is no longer practicing as a social work assistant and does not need the registration. RUSSELL-CAMPBELL'S failure to comply with the audit requirement constitutes a violation of Ohio Revised Code Section 4757.36(C) (1) and Ohio Administrative Code Section 4757-11-01 (C)(20)(b).
3. RUSSELL-CAMPBELL admits the allegation referenced in paragraph 2 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, **RUSSELL-CAMPBELL** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

The **BOARD** will allow **RUSSELL-CAMPBELL** to surrender her social work assistant registration in lieu of other potential disciplinary action.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **RUSSELL-CAMPBELL** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **RUSSELL-CAMPBELL** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

RUSSELL-CAMPBELL hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq., the **BOARD** may be required to provide **RUSSELL-CAMPBELL'S** social security number to requesting governmental agencies. The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its July 2013, meeting.

This **CONSENT AGREEMENT** shall take effect upon the date of the Board Chair's signature below:
