9. **NEW BUSINESS:**

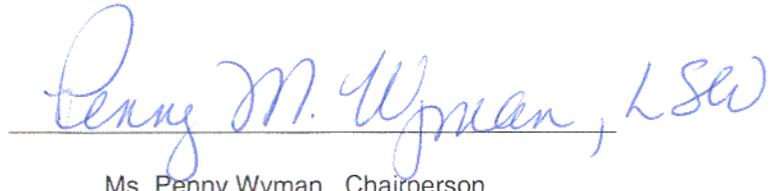
*Glen spoke to the Ohio Health Care Assoc.
